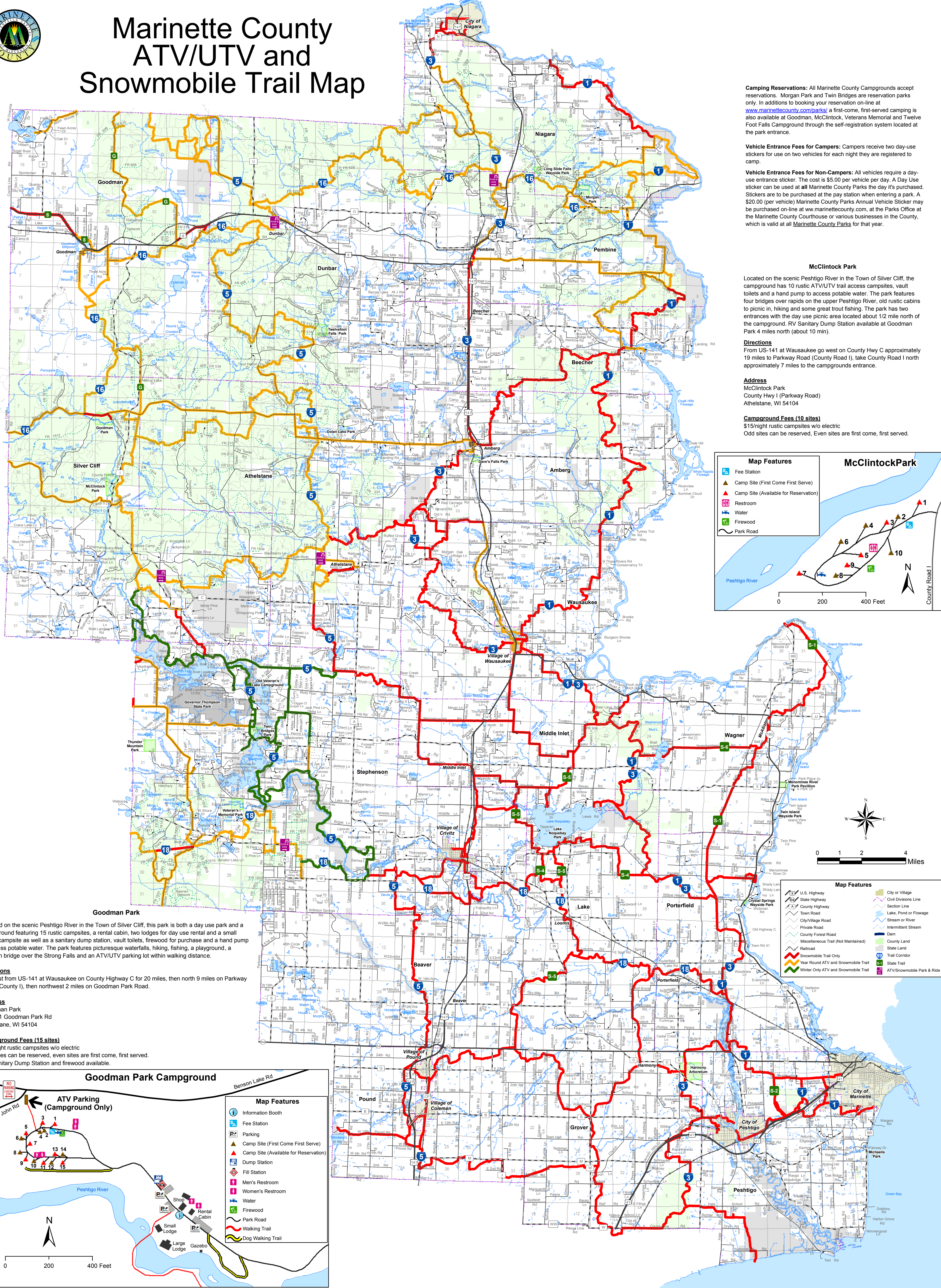




# Marinette County ATV/UTV and Snowmobile Trail Map



**Camping Reservations:** All Marinette County Campgrounds accept reservations. Morgan Park and Twin Bridges are reservation parks only. In addition to booking your reservation on-line at [www.marinettecounty.com/parks/](http://www.marinettecounty.com/parks/), a first-come, first-served camping is also available at Goodman, McClintock, Veterans Memorial and Twelve Foot Falls Campground through the self-registration system located at the park entrance.

**Vehicle Entrance Fees for Campers:** Campers receive two day-use stickers for use on two vehicles for each night they are registered to camp.

**Vehicle Entrance Fees for Non-Campers:** All vehicles require a day-use entrance sticker. The cost is \$5.00 per vehicle per day. A Day Use sticker can be used at all Marinette County Parks the day it's purchased. Stickers are to be purchased at the pay station when entering a park. A \$20.00 (per vehicle) Marinette County Parks Annual Vehicle Sticker may be purchased on-line at [www.marinettecounty.com](http://www.marinettecounty.com), at the Parks Office at the Marinette County Courthouse or various businesses in the County, which is valid at all Marinette County Parks for that year.

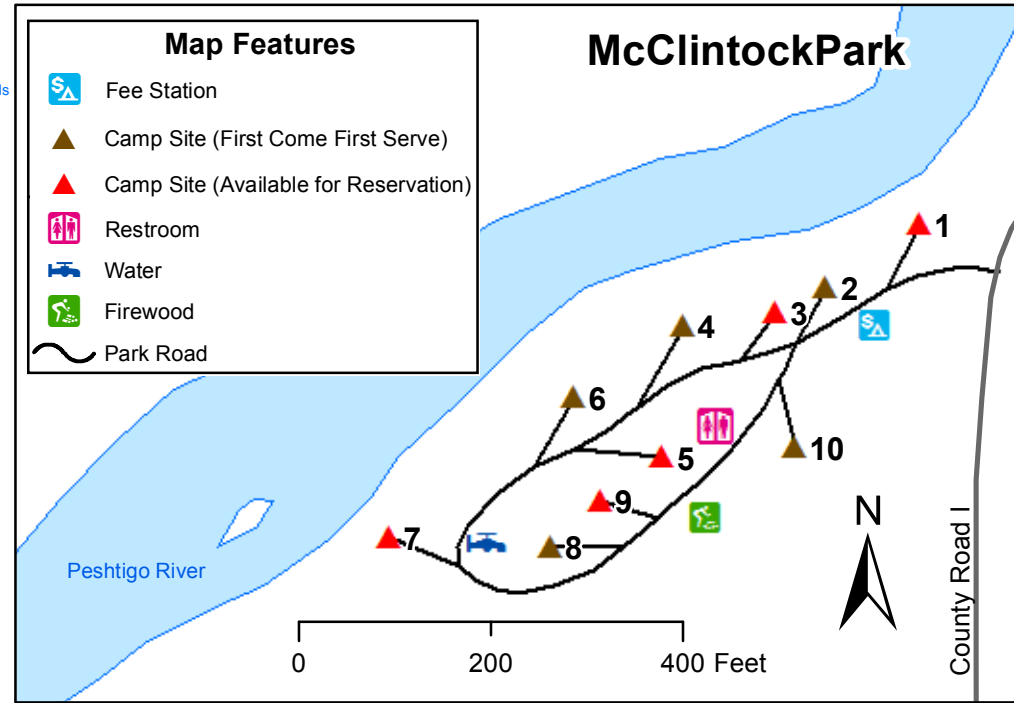
### McClintock Park

Located on the scenic Peshtigo River in the Town of Silver Cliff, the campground has 10 rustic ATV/UTV trail access campsites, vault toilets and a hand pump to access potable water. The park features four bridges over rapids on the upper Peshtigo River, old rustic cabins to picnic in, hiking and some great trout fishing. The park has two entrances with the day use picnic area located about 1/2 mile north of the campground. RV Sanitary Dump Station available at Goodman Park 4 miles north (about 10 min).

**Directions**  
From US-141 at Wausaukee go west on County Hwy C approximately 19 miles to Parkway Road (County Road I), take County Road I north approximately 7 miles to the campgrounds entrance.

**Campground Fees (10 sites)**  
\$15/night rustic campsites w/o electric  
Odd sites can be reserved. Even sites are first come, first served.



Located on the scenic Peshtigo River in the Town of Silver Cliff, this park is both a day use park and a campground featuring 15 rustic campsites, a rental cabin, two lodges for day use rental and a small group campsite as well as a sanitary dump station, vault toilets, firewood for purchase and a hand pump to access potable water. The park features picturesque waterfalls, hiking, fishing, a playground, a wooden bridge over the Strong Falls and an ATV/UTV parking lot within walking distance.

**Directions**  
Go west from US-141 at Wausaukee on County Highway C for 20 miles, then north 9 miles on Parkway Road (County I), then northwest 2 miles on Goodman Park Road.
